

The discussion broadened to include consideration of additional funding by way of Rural Communities Development grant which Ms Blackmore confirmed provided an ideal opportunity to lever "match funding" to expand on that receivable under the S106 agreement.

First stage in the process is the completion of an Expression of Interest which should be submitted before the end of the year otherwise the Vale may proceed with a reduced scheme based on S106 funding alone.

All works to be funded under the Rural Communities Development Fund have to be completed by October 2018.
