Minutes of an Ordinary Meeting of Penllyn Community Council held at
Llansannor Community Hall, City at 7.00 p.m. on Monday
4th September 2017

98) CLLR DAVID PUGH

The Chairman reported the very sad news of the death of the Council's immediate past Chairman, Cllr. David Pugh, who died 8th August 2017.

PC Stuart Elston in attendance.

102) Vale of Glamorgan Council matters.

Highways matters – New issues were raised as follows:

- (i) Penllyn (Cllr Fardo) - Concerns regarding highways reinstatement after BT works, Cllr Cox to pursue.
- (ii) Ystradowen, Edenbrook (Cllr Fardo) – Safety concerns regarding attenuation ponds / soakaways hazards to children, pursue with Vale Council's Head of Planning.
- (iii) "White lines" (Minute 89 (vi) July 17 refers) (Cllr A Hill) – Cllr Cox advised he had pursued the matter and was awaiting a response.

Penllyn Village Hall – The Chairman raised concerns with Cllr Jarvie regarding correspondence received from Regulatory Services, Cllr Jarvie agreed to pursue.

103) Chairman / Member's Report and Communication.

(a) Broadband Ystradowen / Trerhyngyll area (Minute 90 (a) July 2017 refers)

Cllr Smith apprised Council of the current situation, that Bellways the developers at Edenbrook had pursued the matter at a high level with BT, and that BT had given an undertaking that Ystradowen would be connected by 1st October 2017. Further public meetings with BT and with Alan Cairns MP are anticipated later this month.

Cllrs. Smith advised that representatives of Ystradowen Community & Sports Assoc. would be attending the next meeting to apprise members of progress.

- (b) Trees and improvements to the grass surface of the playing field – Remain outstanding, the Clerk presented details of a survey to the trees undertaken by Acorn Tree Services, works required and the estimated cost thereof.
- (c) Playground equipment – It was agreed that the present equipment was obsolete and required replacement.

Resolved: The Vale Council be advised there are good grounds to argue that the status quo should prevail, and that as a large part of the development falls within the Penllyn community there is no justification whatsoever in moving the boundary and that there is precedent elsewhere in the Vale to support this stance.
