Minutes of an Ordinary Meeting of Penllyn Community Council held
at the Llansannor Community Hall, City

131) Apologies for absence

132) Declarations of interest under the Council's Code of Conduct

133) To approve the minutes of the Council meeting held on 1st September 2025.

Resolved: The draft minutes be approved.

134) Matters arising from minutes other than appearing below

(a) Highways matters, new sign request , lane Graig Penllyn to Ruthin quarries , “Unsuitable for HGV’s” (Minute 121 (a) (i) refers).

Clerk reported on response from Vale highways 1st October 2025 accepting the need for the signs but unable to commit to their installation in any time frame due to nonavailability of funding.

(b) Highways matters, existing signs requiring maintenance / replacement, south of Llansannor school and at Trerhyngyll children’s playground(Minute 121 (a) (ii) refers).

Clerk reported on response from Vale highways 26th September 2025 confirming maintenance / replacement will be carried out as necessary.

(c) Meeting with Cowbridge Town Council, “matters of common interest”, inaugural meeting of Western Vale Town & Community Councils Liaison Group. (Cllr Summers in attendance) (Minute 122 refers). Cllr Summers circulated all members with a report on that discussed. The consensus was that there were many areas where communication and co-operation with the Vale of Glamorgan Council needed to and could be improved by a collaborative and united approach from the smaller TCC’s of the Western Vale. Areas of particular note, included some very familiar to our council:

- (i) Failure of local Vale Councillors generally to communicate and or provide a channel between the TCC and the Vale Council
- (ii) Doubts about the effectiveness of the Vale Community Liaison Committee.
- (iii) Difficulties locating and communicating with Vale Council Officers and departments.
- (iv) General feeling that the Vale paid little attention or regard for “the Charter” in its dealings with the Western TCC’s

The group will continue to meet at appropriate intervals to draw up and present to the Vale proposals to improve on the above.

(d) Brigham Farm, Llansannor – land stripping (Minute 121 (b) (i) refers). As resolved Clerk confirmed that he had reported the above to Vale Planning and also Vale enforcement. Cllr Summers updated Council on his further exchange’s with the Vale and requests for information sent to National Resources Wales to confirm or otherwise compliance on site with that “permitted”.

(e) Review of highway 20MPH speed limits – Welsh Government revised guidance (Minute 121 (b) (i) refers). Cllr A. Jarvis update Council on her attendance at Ystradgyniadwr Community & Sports Association meeting 16th. September 2025.
