- (a) Adopted "One lane highways" Grass growing down centre.

Cllr Cox requested details of any roads as above, request already circulated to all Members for details to be forwarded to the Clerk.

(b) Accessibility Survey Ystradowen (dropped kerbs etc.)

This matter had previously been raised by Dr Chris Howard, Ystradowen Community & Sports Assoc., (Minute 5 (b) January 2017 refers).

Cllr. Howells to provide the Clerk with a basic survey for forwarding to Vale Council.

(c) Darren Farm development – Removal of hedges (Minute 29 (a) March 2017 refers)

Clerk advised that subsequent to the last meeting of Council he had been contacted by Cllr Cox and advised no action necessary as the Vale Council had already issued a stop order to the developer resulting in the works being suspended.

(d) S106 (T&CPAct 1990) Funds, Education Receipts-

Cllr Jarvie had previously confirmed £85k was allocated to Llansannor School the balance of the £353k receipt remains outstanding as unallocated. (Minute 17 (b) February 2017 refers).

Cllr Thomas raised his further concerns regarding the adequacy of the £85k to provide anything more than the basic building shell and requested information regarding the procurement process and a detailed breakdown of the project cost including anticipated fees.

(e) Road traffic accidents, Ystradowen "s bends".

Concern had previously been expressed regarding recent accidents, reinstatement of chevrons, and the road camber. (Minute 106 (a) November 16 refers)

There were also concerns regarding flooding, Cllr Cox advised that he had contacted Vale highways who had carried out works to a gully and were now monitoring the situation.

Members also expressed concern regarding the display of a developers sign on the bend.

Resolved: Clerk to pursue outstanding matters with Vale highways.
