Minutes of an Ordinary Meeting of Penllyn Community Council held at Llansannor Community Hall, City at 7.00 p.m. on Monday

## 1) Apologies for absence.

3) Local Lettings Policy, Eden Vale, Ystradowen – Presentation by Mr Alan Sinclair & Ms Megan Lewis, Visible & Housing Services, Vale of Glamorgan Council.

**Resolved:** That Mr Sinclair &Ms Lewis be thanked for their presentation and that the policy as set out below be approved:

#### "Ystradowen - Local Lettings and Sales Policy

United Welsh Housing Association (UWHA) are a major registered social landlord and work closely with Local Authorities, including the Vale of Glamorgan Council (VOG). UWHA are also members of the VOG choice-based allocations scheme HOMES4U.

The aim of this lettings and sales policy is to ensure that the new development in Ystradowen is sustainable and will become part of the local community in which residents wish to remain and show a commitment to the locality in which they will live. To achieve this aim, a local lettings policy for this new development has been agreed with the VOG and Penllyn Community Council, which represents the residents of Ystradowen.

All lettings and sales should satisfy the main principles of the lettings policy which are as follows:

1) Priority will be given to those applicants with a local connection to Ystradowen.

Local connection will be defined as follows:

- Resident in Ystradowen for the last 12 months or 3 out of the last 5 years
   OR
- Parents or close family (see note below) currently living in Ystradowen for 5 years or more or, failing that, for 2 to 5 years OR
- Permanently employed (or moving to be permanently employed) in Ystradowen or Penllyn Community Council area **OR**
- Retiring from tied accommodation in Penllyn Community Council area

Note: Close family members include husband or wife, grandparents, parents, children, grandchildren, brothers, sisters, uncles, aunts, nephews & nieces. Step and half relatives will be treated as full blood relatives.

2) When allocating all properties at the scheme, if there are insufficient HOMES4U applicants with a local connection to Ystradowen then priority will next be given to applicants from the wider Penllyn Community Council area.

After taking into account point (1) and (2) above, properties will be allocated in line with current HOMES4U policy, by band priority and by the length of time registered with HOMES4U.

In respect of the low cost home ownership properties, eligible applicants will be prioritised by length of time registered with Aspire2Own, subject to meeting the eligibility requirements for the purchase.

- 3) If there are insufficient HOMES4U applicants at level (2), then applicants will be considered from the adjacent community council areas, in particular, Welsh St. Donats, Llangan and Cowbridge Town Council area.
- 4) In the unlikely event that there are insufficient applicants taking into account points (1) and (3) above, then applicants will be accepted from the rest of the rural Vale and
- 5) Finally applicants will be considered from the Vale of Glamorgan as a whole
- 6) When letting properties at Eden Brook, we will match the size of the accommodation with the household's needs, in line with current allocation policies.

Nothing in this document precludes new application to HOMES4U.

For all applicants who are housed in rented accommodation at Eden Brook home visits will be undertaken by Housing Officers and tenancy references will be taken up, including for those applicants living in private accommodation.

UWHA and VOG will provide feedback on the outcomes of the lettings policy to Penllyn Community Council."

One crime only during March, burglary, report of a suspicious male looking into windows of an empty property, officers attended and an arrest made, circumstances of which were elaborated on by Cllr. M Smith.

At the request of Cllr. MR Lewis at last month's meeting, a message to dog owners regarding the control of their dogs particularly during the current lambing season had been circulated via Facebook.

#### 7) Vale of Glamorgan Council matters.

- (a) Update on issues raised at previous meetings:
- (i) RTA Ystradowen Site meeting with Vale Council officers 02<sup>nd</sup> February 2016 (Minute No. 13 (i) February 2016 and 5 (a) (i) March 2016 refer).

As requested at last Council, both Cllr. Cox and The Clerk had contacted the Vale Council for feedback from the site meeting as above.

Response received from Vale Council, Senior Transportation Officer, Visible Services & Transport, email dated 30<sup>th</sup> March 2016 as follows:

"Following on from our recent meeting I can confirm the following:

- The school bus to Cowbridge now only picks up on the side of the road where the bus shelter is located (looping around by the garage to head towards Cowbridge):
- The shelter has capacity to cope with the numbers who are being taken to school;

From a Highways side I am afraid I can only make reference to the comments that Steve made when we were all on site together:

- The speed on the road is what is expected in such an area;
- There is little scope of putting a shelter on the opposite side of the road due to the size of the pavement and bank that lays behind it;
- There was no scope to move the bus pick-ups into Tymawr Close due to the tightness of the turns and the fact the buses would block residents drives and no guarantee could be given that the close would always be clear for buses to enter and depart.
- The pedestrian crossing allows pupils the opportunity, with good line of sight, to cross the road. It is, however, recommended that all wishing to cross the road do so at the pedestrian crossing.

We will continue to monitor the situation and I have asked Peyton Travel who run the school buses into Ystradowen to let me know if any issues do arise.

If my memory serves me well I do recall Steve mentioning that he could get an officer with a speed gun device to monitor the speeds travelling through Ystradowen near to the crossing. This would then give an indication of the speed that vehicles are travelling through the area. I will chase this up with the Highways team."

Cllr Pugh suggested additional 30 MPH signs, lighted & flashing, be erected to the north of the village.

**Resolved**: Clerk to write to Vale Council Highways requesting signs as above, and that the provision of the additional bus shelter be added to the Council's S106 "wish list" and forwarded to Vale Planning.
