#### Minutes of an Ordinary Meeting of Penllyn Community Council held at Llansannor Community Hall, City at 7.00 p.m. on Monday 3<sup>rd</sup> July 2019

(b) Grass cutting verges and hedges

**Resolved:** Clerk to write to Vale highways regarding all of the lanes in the Penllyn area, specifically the routes from Ystradowen to Llanharry, Llanharry to Penllyn, and around Llansannor.

(b) Edenbrook Development, attenuation ponds (Cllr JE Evans) (Minute 66 (B) (a) Council June 19 refers) update

There had recently been issues with algae build up in the ponds which is being pursued. Also pre-seeded matting had not resulted in spring flowers probably due to lack of watering by contractor during a very dry April. The few meadow flowers above the bank being those planted by residents in May.

(c) Boundary Commission, review of electoral arrangements in the Vale, consultation (Minute No. 66 (B) (c) refers)

**Resolved:** Respond to consultation in support of the views of the Vale Councillors, and the Vale Council, that the existing number of Vale Councillors for the Cowbridge ward should remain unchanged. (Vale Council cabinet 15.07.19 refers)

(d) Darran Farm S106 receipts (Cllr Cox) (Minute No. 66 (B) (d) refers)

Members had previously expressed views that this development would impact upon Penllyn and as such a "wish list" of projects for funding should be prepared.

The Clerk reported, in accordance with that previously resolved, he had written to the Vale Council. Whilst there was no indication forthcoming as to when funds might become available, confirmation was received that any proposals for the application of this funding would be welcomed for consideration. (email from Vale Council 24.06.19 refers)

#### Resolved: Noted

(e) Badgers Brook S106 receipts (Cllr Parker) (Minute No. 66 (B) (d) refers)

Further discussion took place regarding the possibilities for reallocating the c £80k currently allocated to providing a footpath on the Ystradowen Rd. nr Watery Lane.

Discussion ensued that even if the pavement as proposed were to proceed there would be other places where there is no pavement on one side or the other where

pedestrians would still have to cross.

Members considered two alternative proposals that the funds be :

- (i) Reserved to contribute towards the provision of a full length footpath between Cowbridge Comp School and Ystradowen as and when sufficient funding becomes available, alternatively
- (ii) Applied towards a bus shelter and dropped kerbs in Ystradowen.

**Resolved:** That following a vote by show of hands, the Vale Council be advised that the Council's preference is changed to the provision of a bus shelter and dropped kerbs in Ystradowen.

Note: Vale of Glamorgan Councillor GA Cox left meeting following consideration of the matter as above.
