(A) Highways matters:

(a) Schedule of outstanding and ongoing highways issues.

(i) Badgers Brook, Ystradowen, access from A4222, parking (Cllr. Evans) (Minute 73 (A) (a) (i) May 2021 refers) – Clerk wrote to Vale highways 21st April 2021 regarding access off the main road, other inappropriate parking, the poor state of the highway surface, the implications of possible further development in Sandy Lane, and requesting a site meeting.

Vale highways responded 22ndApril 2021 declining to meet on site vis without any further comment on the issues raised, other than to refer to the Sandy Lane issue being a matter for Planning to resolve.

(ii) Request for traffic calming measures in Ystradowen (A4222) (Cllr. Howells) (Minute 73 (A) (a) (iii) May 2021 refers) – Clerk reported on response from Vale highways 28th June 2021 that, as there had been no instances of serious personal injury, further traffic calming measures could not be justified.

Resolved: Clerk to write further to Vale highways expressing Council's disappointment with the response received as above, reiterate the previous request that further traffic surveys be conducted at both ends of the village, and request the cost of suitable flashing LED speed warning lights for the village.

(iii) Trerhyngyll highways surface (Cllr. Bancroft) (Minute 50 (A)(a) (ii) April 2021 refers) – Notwithstanding that the need for overall resurfacing of areas, vis rather than patching, was accepted by the Vale, minute as above refers, no such resurfacing work had taken place and complaints were being received from residents.
