Minutes of an Ordinary Meeting of Penllyn Community Council held at Llansannor Community Hall, City at 7.00 p.m. on Monday 6th January 2020

154) Vale of Glamorgan Council matters.

(A) Highways matters:

Items from last Council:

- (a) Junction between Trebettyn to City road and Llansannor Hill road between Church Farm and Court Farm Flooding
- (b)Penllyn to Llanharry road between Brigam farm and Degar Flooding

It was reported that Vale Council employees had been seen at both sites and a cone placed in the broken drain at court farm, however the flooding at both sites appears to still be continuing on a regular basis without any visible signs of improvement, clearly more or alternative work needs to be undertaken to find permanent, effective solutions which will prevent these repeated and dangerous occurrences. (Cllr Summers)

New items:

(c) Resurfacing lanes - Reducing width through resurfacing only the visible highway.

Due to yearly growth, mud, falling leaves etc the edges are masked year on year, so the next resurfacing treats a narrowed area.

Members mentioned a number of instances where householders had been aghast at contractors intending to leave large strips either side of the carriageway just because the grass had sprouted up there.

Members questioned why resurfacing work appears not to include for clearing the edges of the carriageway vis to maintain road width ,and / or why contractors are not subject to greater supervision.(Cllr Petty)

Members also made specific mention of the state of the lanes / roads around Llansannor school, the breakup of road edges probably caused by parents parking and or driving off those edges to avoid parked vehicles on the opposite side.

The traffic and parking at the school has caused both the verges to be worn back and the original road edges to broken back.

Again, as referred to above, the 'extended ' road has never been properly resurfaced across the full width.

If the full width of these extended areas was properly compacted and tarmacked it would at least prevent further degradation. (Cllr Summers)

(d) Fire hydrants – Location and maintenance (Cllr Lewis)

At a recent fire off Ash Hill Rd. Ystradowen it appeared the fire brigade were not familiar with the location of hydrants and that hydrants had been tarmacked over.

Members requested the Clerk to also pursue this matter with Welsh Water and South Wales Fire Service.

- (e) Developing possible "sink hole" Forest Rd, Ystradowen, past Ash Hall Rd, threequarters of way towards Crofta Farm, safety hazard to vehicles. (Cllrs Smith & A. Jarvis)
- (f) Subsidence in carriageway Unnamed road, beyond Crofta Farm towards property Tymaen 50 yds past Tymaen culvert under road collapsing. (Cllr A.Jarvis)

Members requested the Clerk to also forward correspondence on this to Vale Members for them to also pursue.

(g) Finger posts – Repair and maintenance (Cllr Summers)

Cllr Summers to provide location of signs in question.
